- Polygamy dates back to the time before Jesus. Is found in the Old Testament and over 40 important figures had more than one wife
- Early followers of Polygamy argue that God had required them to do so because some Old Testament prophets had more than one wife.
- Throughout history many religions like Christianity, Roman Catholic Church Hinduism, Buddhism and many others, have practice Polygamy at one point.
- Polygamy was a normal practice among wealthy man like royals who had the money to pay for more than one wife.
- In other cultures Polygamy was also allowed and seem as a way to bring wealth to the family because the more children they had the more the more hands to farm.
- LDS leaders announced plural marriages as an official Mormon Church practice in 1852

Cultures around the world that still practice Polygamy

- It shows that polygamy is permitted in countries predominantly in Africa and Asia, including Algeria, Mali, Nigeria, Saudi Arabia and Iran.
- Europe, Australia and America are included in the areas where polygamy is fully outlawed.
- Mormon communities in the U.S practice Polygamy
- In 2000, the overall prevalence of polygamy was 28 percent in the 34 countries









Why is Polygamy illegal in the U.S?

- Married couples in the U.S receive many benefits, it will be to expensive for the government to pay benefits to more than one spouse.
- Employers who provide health insurance for the employee and spouse, would have to pay more coverage if the employee has more than one spouse.
- Allowing polygamy would violate not only the Equal Protection Clause of the Fourteenth Amendment
- The Human Rights Committee said, it violates women's dignity rights and is an "inadmissible discrimination" against them
- Polygamist families also have a higher rate of child abuse and child neglect
- Is anticonstitucional
